PHILLIMORE'S MARRIAGES - GOADBY MARWOOD 1657 TO 1837

This is one of many parishes which has lost its early Register, which covered the period 1542 to 1655.

The existing first Volume begins in 1656 and registers Burials and Baptisms from 1656 to 1789, and Marriages 1657 to 1790. It consists of 3 blank paper flyleaves at the beginning, none at end, 34 parchment leaves measuring about 12 by 7 7/8 inches; length varies somewhat; bound in parchment boards, in which the book is loose.

The first entry is—

"Katherine, the daughter of Sr. George Villiers and Dame Margaret his wife was buried Jan: 9th 1656."

Under 1739, Nov. 14th, occurs—

"Mary (daughter of a beggar who said her husband was one Jacob Myers, first a Jew and afterwards a Convert, and killed and buried at Doncaster) baptised; without sponsor. Myers (no Hebrew) but a Yorkshire name" *[sic]

1751. Aug. 4th (Sunday) is a Memorandum of a Private Ordination by the RR. John Thomas, Lord Bishop of Lincoln, when the Rev. Nathanael Smith, Vicar of Hough, co. Linc., was admitted into Priests Orders.

The writing is generally good, especially that of the Rev. Francis Peck, vicar, who would seem to have been a Surrogate judging by the number of licensed marriages of non-residents, which may easily make this register important.
